FURTHER ORDERED: IF APPELLANT(S)' FILING FEE IS NOT PAID ON OR BEFORE **October 30, 2024**, THE CASE SHALL BE DISMISSED. NO FILINGS BY APPELLANT WILL BE ACCEPTED UNTIL THE APPELLANT'S FEE IS PAID.

FURTHER ORDERED: Pursuant to Rule 12(b)(2), Ariz. R. Civ. App. P., Appellant's Opening Brief shall be filed on or before **December 16, 2024**.

FURTHER ORDERED: Appellees fee in the Court of Appeals, Division Two, is \$140.00, (\$280.00 if Appellee has filed a cross-appeal), pursuant to A.R.S. 12-321. Fees must be paid in cash or check made payable to the Court of Appeals. NO FILINGS BY APPELLEE WILL BE ACCEPTED UNTIL THE APPELLEE'S FEE IS PAID.

FURTHER ORDERED: BRIEFS NOT IN COMPLIANCE WITH ARIZ. R. CIV. APP. P. 14 WILL BE STRICKEN.
