**REQUEST FOR JUDICIAL  
NOTICE**

To support his Response to the State Bar’s Motion for Partial Judgment on the Pleadings, and to further support his position either at trial and/or in future dispositive motions, pursuant to Ariz. R. Evid. 201(c)(2), Respondent David S. Gingras (“Respondent” or “Gingras”) respectfully asks the Court to take notice of certain records reflected in the table below. Because Respondent has supplied the Court with the “necessary information” to support this request, judicial notice is mandatory, not optional; “[the court] ... must take judicial notice if a party requests it and the court is supplied with the necessary information.” Ariz. R. Evid. 201(c)(2).

Judicial notice is proper because the records all relate to the Superior Court matter (*Owens v. Echard*) which gives rise to this case. It is well-settled “a court may properly take judicial notice of its own records.” *State v. Rhome*, 235 Ariz. 459, 461, 333 P.3d 786, 788 (App. 2014); *see also Briggs v. Montgomery*, 2019 WL 2515950, \*5 (D.Ariz. 2019) (“The Court ‘may take judicial notice of court filings ... and ‘[i]t is also well established that a ... court can take judicial notice of its own records.’”) (quoting *Baca ex rel. Nominal Defendant Insight Enterprises, Inc. v. Crown*, 2010 WL 2812712, \*2 (D.Ariz. 2010)).

To be clear – the index below reflects the complete docket listing of all pleadings filed in *Owens v. Echard*, FC2023-052114. However, in the interests of efficiency, Respondent has only provided this Court with a limited selection of pleadings (only those reflected in **bold text** below) which are relevant to this matter. Respondent only requests that judicial notice be taken as to those pleadings attached to this notice.
